Guidelines for Using Licensed Trademarks

To protect the value of the licensed trademarks, there are rules that must be followed when using the trademark in all communications.

1. Always use the trademark as an adjective followed by generic words. It is not necessary to use a generic work or symbol (® or ™) when using the trademark as a company name.
For Example: RightAnswer.com's database
(trademark) (generic)

2. The first use of the trademark in a title or copy must be followed by a "™" if the trademark application is not yet registered or "®" if the trademark is registered.

3. On labels and other promotional materials, always use the following footnote trademarks (inserting the appropriate trademarks and their owners in the following statement):

For registered – example: RightAnswer® is a registered trademark of RightAnswer.com, Inc. All rights reserved.

For unregistered (the ones in the list with a ™ or no symbol) — example: WebInsight is a trademark of Ariel Research Company. All rights reserved.

4. Always use the trademark exactly as it is registered. Do not change the spelling or design.
5. Never combine a trademark with another trademark.
6. Always specify your relationship to RightAnswer.com on labels and other promotional material.
